

OFFICIAL CALL

Mass Meeting of the Middlesex County Republican Committee of the Republican Party of Virginia

As Chairman of **Middlesex County Republican Committee** of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Sandra Lent do hereby issue this call for a Mass Meeting to be held at Cooks Corner Office Complex, 2911 General Puller Highway, Saluda, VA, 23149 on **March 19, 2013 starting at 7 p.m.** with registration beginning at 6:15 p.m. for the following purposes:

- A. Electing up to 125 Delegates and an equal number of Alternates to the Republican Party of Virginia's State Convention, to be held on Friday May 17th and Saturday May 18th, 2013 at the Richmond Coliseum located at 601 East Leigh Street, Richmond, Virginia beginning at 2:00 PM local time on Friday May 17th [No voting for candidates for the office of Governor, Lt. Governor or Attorney General will be conducted prior to 12:00PM local time on Saturday May 18, 2013] for the purposes of nominating a Republican candidate for Governor, Lt. Governor, and Attorney General. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Middlesex County Republican Committee is entitled to 25 Delegate Votes;
- B. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Middlesex County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for the election at said mass meeting shall file a written statement by mail or in person, to Sandra Lent 379 Sunset Vista Drive, which must be received **not later than 7:00 p.m on March 12, 2013**. Postmarks will not govern. The filing form can be picked up from Sandra Lent at 379 Sunset Vista Drive and online at www.RPV.org, www.va1gop.org or www.middlesexgop.org.

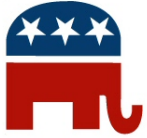

Registration Fee

There is no registration fee required to participate in the mass meeting. All registrants will be required to show proper identification and to declare their voting district.

The Republican Party of Virginia is requesting a voluntary \$35 filing fee from all individuals seeking election as a Delegate to the State Convention. Checks need to be made out to MCRC.
