NOTICE OF A CALL FOR THE NEWPORT NEWS VA REPUBLICAN CITY COMMITTEE MASS MEETING ON APRIL 16, 2013

As Chairman of the Newport News city Committee of the Republican Party of Virginia and pursuant to the Plan of Organization, and as recommended and directed by the Committee, I, W. Cliff Dunn do hereby issue the Call for a Mass Meeting to be held on April 16, 2013, at 6:30 p.m. local time at MidTown Recreation Center, 570 McLawhorne Dr., Newport News VA. Registration starts at 5:30 p.m. local time, and closes at 6:20 p.m. local time. A picture ID is required. The Mass Meeting will elect up to 915 qualified Delegates to cast 183 votes at the Virginia State Republican Convention on Friday, May 17, 2013, at the Richmond Coliseum located at 601 East Leigh St, Richmond VA, beginning at 2:00 p.m. local time.

PURPOSE OF THE STATE CONVENTION

The purpose of the Convention to nominate Republican Candidates for Governor, Lt. Governor, and Attorney General in the November, 2013 General Election. Balloting for these positions will begin after 12:00 p.m. on Saturday, May 18, 2013.

QUALIFICATIONS FOR PARTICIPATION

All legal residents, who are qualified voters of Newport News, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

FILING REQUIREMENTS

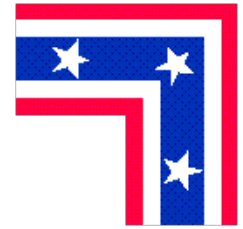
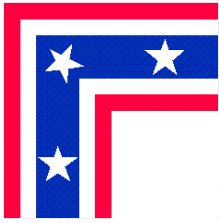
Any person, who wishes to be a Delegate must be a resident and registered voter in Newport News. To apply, a form must be completed. Obtain those forms from Nan Rothfuss, Secretary, at docandnan@juno.com. Applications for Delegate must be received by Nan Rothfuss, 97 Shamrock Lane, Newport News VA 23606 (757-930-0644) or at docandnan@juno.com not later than 5:00 p.m. local time on April 6, 2013. Postmarks do not count. They may be received by mail, Email, or hand delivered and must have an original signature. No nominations may be made from the floor of the Mass Meeting by virtue of the prefiling requirements. If fewer candidates file for Delegate than spaces available, all properly filed, qualified Delegates will be deemed elected, and the Mass Meeting will be canceled. In any event, the elected Delegation will attend the State Convention uninstructed and under the full vote rule. Resolutions to be presented at the Mass Meeting must follow Resolution format, and be submitted under the same circumstances as above.

REGISTRATION FEES

There is a voluntary \$5.00 registration fee required to participate in the Mass Meeting, to offset the cost of the newspaper ad. No prefiling is required to attend the Mass Meeting.

Registration for the State Convention is a voluntary \$35.00. Unit delegations with the most Delegates paying the fee will be given preferential seating for the Convention.
